DESCRIPTION:

The Onji Akiing (From the Earth) Cultural Summer Camp Program is a collaborative effort between the Great Lakes Indian Fish and Wildlife Commission and the United States Dept. of Agriculture- Forest Service. The camp centers around the Medicine Wheel, addressing not only the physical but also the emotional, mental, and spiritual aspects of adventure-based learning workshops to promote treaty right awareness and practice, strengthen relationships with the outdoors, and foster natural resource careers infused with traditional ecological knowledge for youth entering 5-8th grade.

RESPONSIBILITIES:

- 1. Oversee the health of campers and staff of approximately 80 in total.
- 2. Camper health form review (includes preliminary lice check).
- 3. Identifies health needs for each camper.
- 4. Oversee and maintain proper storage of medications and supplies.
- 5. Triage any injury and illness that may occur.
- 6. Administers over-the-counter and prescription medication.
- 7. Knowledge of public health disease management.
- 8. On-call (including over-night hours).
- 9. Strong communication skills and positive interactions with parents, staff, and youth.
- 10. Enjoys working and living in camp environment.
