Directions for mapping your Shooting Plan:

- 1. Visit the Area You Intend to Hunt.** You must visit the area detailed in the shooting plan at least once during daytime hours from the day after Labor Day to the close of the tribal deer season to complete this Shooting Plan.
- 2. Scout the Location.** Once at the shooting site, scout the location.
- 3. Clearly Mark the Required Items on the Plan.** (See §6.20(5)(a) for complete list).
- 4. Use Reasonable Precaution.** Take reasonable precautions to prevent against the establishment of a non-compliant shooting plan.

Draw a diagram of the area you are going to hunt including your established "Safe Zone of Fire" (the area in which you may safely discharge a weapon, **may be no more than 180 degrees**), "Adequate Backstop" present within one-hundred twenty-five (125) yards from the stationary position, "Stationary Position," "Direction of Intended Fire," and the presence of any "Obstacles" such as roads, buildings, lakes, open areas, campgrounds, other night-hunting sites, etc., within a quarter-mile.
